PROXY STATEMENT OVERVIEW

The Annual General Meeting of Shareholders of SRIVARU Holding Limited (the "Company"), will be held at 8:30 a.m. Eastern Time on August 29, 2024 via Conference Call. You can register for the Meeting at <https://meeting.vstocktransfer.com/SRIVARUAGM24>.

Proposals to be voted at the meeting are listed below along with the Board of Directors' recommendations.

1. A Srivaru proposal to elect Mohanraj Ramasamy as the sole Class I Director for a full term of two (2) years.
2. A Srivaru proposal to ratify the appointment of Manohar Chowdry & Associates as the independent registered public accounting firm for the Company for 2024.
3. A Srivaru proposal to give the Board of Directors discretion to approve a reverse share split at an exchange ratio of up to one-for-fifteen (1:15) within 12 months of the shareholders' approval.
4. A Srivaru proposal that the authorised share capital of the Company be adjusted in proportion to any reverse share split implemented pursuant to Proposal 3.
5. A Srivaru proposal to adopt the third amended and restated memorandum and articles of association to reflect any reverse share split and any related adjustment.
6. A Srivaru proposal to approve the adjournment of the Meeting to a later date or dates to (A) supplement or amend the proxy statement or (B) solicit additional proxies from shareholders in favour of one or more of the proposals.

To act on any other business that may properly come before the Meeting or any reconvened meeting after adjournment.

The Board of Directors recommends a vote "FOR" each of the Proposals No. 1 to No. 6.
