RESOLVED, as an ordinary resolution, that the reduction of the par value of all issued and unissued ordinary shares from US\$0.50 to US\$0.0001 per share and the authorized share capital of the Company remain US\$10,000,000 and the resulting amendment to the Company's Memorandum and Articles of Association.
